NOTICE OF LIEN CLAIM

The Department of Employment Commissioner of Oregon hereby claims a lien in the amount of \$151.25 with interest on \$149.75 at the rate of one percent per month, or fraction thereof, until paid, upon:

any and all of the real and personal property of whatsoever kind or nature belonging to the defendant, lying or being situated in Klamath County, Oregon, and upon all personal property of whatsoever kind and nature situated upon the above premises manufactured by defendant and upon which labor has been performed by workmen of defendant, including but not limited to:

13 Pallets of tied shook located in the parking lot front of new metal building.
19 Pallets of banded 2 x 4 studs stacked near the road leading to the highway. Approximately 20 feet from the road.
16 Pallets of 2 x 4 studs stacked around the North edge of the empty pond.

Said lien is claimed for a sum equal to unpaid taxes due and payable for the first calendar quarter of 1969

in the amount of \$149.75 taxes and \$1.50 interest, with interest on \$149.75 at the rate of one percent per month, or fraction thereof, from the 31st day of May, 1969, until paid, XXXXXXXXXXXXXXXXXXXXXXX

These taxes are assessed under the provisions of ORS 657.681 (4)
