DECREE OF DIVORCE

This action coming on regularly for trial before the Court on this 6th day of July, 1943, Messrs. Ham & Taylor appearing as Attorneys for the plaintiff, the defendant having been duly served with summons and having failed to appear, plead or answer within the time provided by law and default having been regularly entered against the said defendant, upon the Complaint of the plaintiff and all the records and files herein, and the plaintiff introducing evidence in support of the allegations of his Complaint, the defendant not introducing evidence, and the Court being fully advised in the premises, and finding that the plaintiff is now and for more than six weeks prior to the commencement of this action and ever since has been an actual, bona fide resident and domiciliary of the State of Nevada, actually and physically residing and being domiciled therein during all of said periods of time, and that this Court has jurisdiction over both of the parties hereto and of this cause of action and that each and every of the allegations contained in plaintiff's Complaint were and are true, and that plaintiff is entitled to the relief prayed for in said Complaint, the Court decides said action in favor of the plaintiff and against the defendant, and

IT IS ORDERED, ADJUDGED AND DECREED that the bonds of matrimony existing between the plaintiff, HENRY G. KLINENBACHER, and the defendant, MAOMA RUTH KLINENBACHER, be, and the same are hereby wholly dissolved and a decree of absolute divorce is hereby granted plaintiff and each of the parties hereto are hereby restored to the status of single persons.
