 thereof on file in the records of Klamath County, Oregon.


9 Subject to: Easements and rights of way of record and those

11 The true and actual consideration paid for this transfer is \$1,000.00.

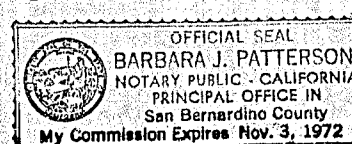
12 TO HAVE AND TO HOLD the said premises with their appurtenances unto the said
