DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, That the undersigned trustee or successor trustee under that certain trust deed dated March 9, 1966, executed and delivered by John F. O'Neil, Sr. and Ruby O'Neil, husband and wife, as grantor and recorded on April 22, 1966, in book M-66 at page 3580 of the Mortgage Records of Klamath County, Oregon, conveying real property situated in said county described as follows:

That portion of Tract 48 of Merrill Tracts described as follows:

Commencing at a point on the line between Sections 2 and 11, which section line marks the center line of the County road and which point of beginning is 425 feet West from the quarter corner common to Sections 2 and 11; thence East along said Section line 75 feet; thence South to the high water line of Lost River; thence Westerly along said Lost River to a point due South of the point of beginning; thence North to the point of beginning.

Excepting County road along North line of said tract,

having received from the beneficiary under said trust deed a written request to reconvey, reciting that the obligation secured by said trust deed has been fully paid and performed, hereby does grant, bargain, sell and convey, but without any covenant or warranty, express or implied, to the person or persons legally entitled thereto, all of the estate held by the undersigned in and to said described premises by virtue of said trust deed.

In construing this instrument and whenever the context hereof so requires, the masculine gender includes the feminine and neuter and the singular includes the plural.
