to them paid by Klamath County, a governmental subdivision of the  
State of Oregon  
grantee  
do hereby grant, bargain, sell and convey unto the said grantee, its heirs and assigns, all  
the following real property, with the tenements, hereditaments and appurtenances, situated in the County  
of Klamath and State of Oregon, bounded and described as follows, to-wit:

A parcel of land for road purposes in First Addition to Altamont Acres  
a subdivision in Klamath County being more particularly described as  
follows:

Beginning at the Southeast corner of Lot 17, Block 4, First Addition  
to Altamont Acres; thence S.0°20' W. 20 feet; thence N.89°27' W. along  
the center line of said vacated street 52.5 feet; thence N.0°20' E. 20 feet;  
thence S.89°27' E. 52.5 feet to the point of beginning, being a portion of  
vacated Tappen Avenue

To Have and to Hold the above described and granted premises unto the said grantee, its  
heirs and assigns forever.
