A portion of Lot 13, HOMEDALE, located in Section 11, Township 39 South, Range 9 E.W.M., more particularly described as follows:

Beginning at an iron pin located South O degrees 20' West a distance of 203.61 feet from the Northwest corner of said Lot 13; thence South 86 degrees 22' East a distance of 124.20 feet to an iron pin; thence South 8 degrees 14' West a distance of 90.83 feet to an iron pin; thence North 87 degrees 16' West a distance of 111.84 feet to an iron pin on the Easterly edge of Homedale Road; thence North O degrees 20' East along the Easterly edge of Homedale Road a distance of 92.29 feet, more or less, to the point of beginning.
