AN ORDINANCE VACATING A PORTION OF PEACH STREET IN ELDORADO ADDITION, TO THE CITY OF KLAMATH FALLS, OREGON; AND DECLARING AN EMERGENCY.

WHEREAS, on October 21, 1968, pursuant to Resolution No. 1704, the Common Council of the City of Klamath Falls, Oregon, held a public hearing on a proposal to vacate a portion of Peach Street, Block 8, Eldorado Addition to the City of Klamath Falls, Oregon, and

WHEREAS, the Common Council of the City of Klamath Falls has determined that it is to the best interest of the City that said street be vacated; therefore,

THE CITY OF KLAMATH FALLS ORDAINS AS FOLLOWS:

Section 1.

The portion of Peach Street described as follows:

Beginning at a 1 1/2" iron pipe on the northeasterly line of Lot 16, Block 8, Eldorado Addition to the City of Klamath Falls, Klamath County, Oregon, said 1 1/2" iron pipe, being S 51°43'30" E a distance of 14.79 feet from the northwesterly corner of said Lot 16; thence northwesterly along the arc of a curve to the right, having a radius of 1,493.96 feet, a distance of 200.43 feet to a 5/8 iron pin; thence South 78°17'33" W a distance of 31.86 feet to a 5/8 iron pin; thence northwesterly along the arc of a curve to the right, having a radius of 83.00 feet, a distance of 72.41 feet to a 5/8 iron pin on the northeasterly line of Lot 11 of said Block 8, said iron pin being North 51°43'30" W a distance of 7.23 feet from the northeasterly corner of said Lot 11; thence South 51°43'30" E, along the northeasterly line of Block 8, a distance of 276.92 feet to the point of beginning;

all in Eldorado Addition to the City of Klamath Falls, Oregon, be, and the same is hereby vacated. save an except an easement for a sanitary sewer.

Section 2.

The immediate enactment of this ordinance being deemed necessary for the preservation of the public peace, health and safety, an emergency is declared to exist, and this ordinance shall be in full force and effect from and after its passage and its approval by the Mayor.
