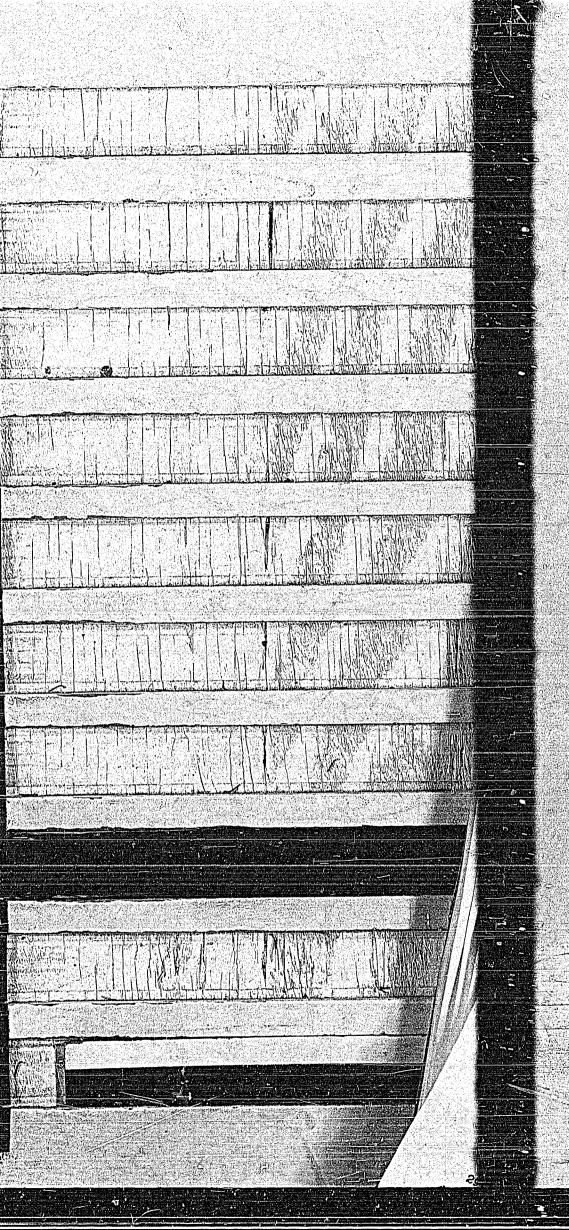

It is mutually agreed that:

1.
