

NOTICE OF VESTED WATER RIGHT

Klamath Indian Reservation, Klamath County, Oregon

TO: State Engineer, Water Resources Department, State of Oregon,
and conflicting water rights claimants and other adverse parties
claiming to own, possess or occupy lands in Klamath County, Oregon.

The undersigned Klamath Indian, Norman Miller Anderson, Sr.
claims and asserts ownership of a vested water right in an amount
reasonably necessary for irrigation, domestic and stock watering
uses appurtenant to the following described parcels of land in
Klamath County, Oregon:

Government Lots 1, 2, 3, 4, and 5, SW 1/4 NE 1/4,
S 1/2 NW 1/4, SW 1/4 of Section 1; Government Lots
1 and 2, S 1/2 NE 1/4, SE 1/4, of Section 2; all
Section 11; all Section 12, W 1/2 of Section 13;
NE 1/4, E 1/2 SE 1/4, of Section 14; all in Township
35 South, Range 12 East of the Willamette Meridian,
EXCEPTING THEREFROM that portion conveyed to A. C.
Yaden and Irene V. Yaden, husband and wife, dated
May 3, 1960, recorded May 25, 1960 in Deed Volume 321
page 402.

The source of the water for the exercise of said water right
is from Ponina Creek and any other waters reasonably necessary for
such purposes.

Said water right owned by the undersigned was reserved in
the treaty concluded on October 14, 1964 (16 Stat. 707), between the
United States of America and the Klamath and Modoc Tribes and the
Uahooskin Band of Snake Indians, establishing said reservation.

The undersigned further claims and asserts a priority for
said water right as of said date of October 14, 1864, when said right
vested with the establishment of said reservation.

Conflicting water right claims may exist in connection
with various lands in said county, including but not necessarily
limited to the following:

WHEREFORE the undersigned claims and asserts that all other
water rights claimed to have vested subsequent to said date of
October 14, 1864, are subordinate to her superior water right to the
