1 of divorce from defendant on the ground that the parties have
2 lived separate and apart for a period of more than three consecu-
3 tive years, without cohabitation, same being final and absolute
4 in form, force and effect, the laws of the State of Nevada pro-
5 viding no interlocutory period or conditions or restrictions on
6 remarriage; and that the bonds of matrimony now and heretofore
7 existing between plaintiff and defendant are fully, completely
8 and forever dissolved and that plaintiff and defendant are both
9 and each hereby restored to the status of single persons.

10 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that de-
11 fendant be, and he hereby is, awarded the care, custody and con-
12 trol of the minor children of the parties, namely MARY DELIGHT
13 BOLEYN and H. DAVID BOLEYN, reserving to the plaintiff the right
14 to see and visit said children at all reasonable times and to
15 have the children with her on alternate holidays and at least
16 two months of each summer vacation.

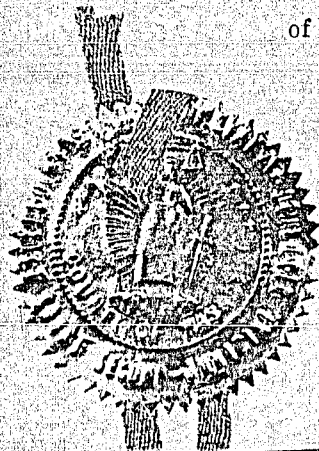
