KNOW ALL MEN BY THESE PRESENTS, That the undersigned trustee or successor trustee under that certain trust deed dated October 13, 1966, executed and delivered by Louie I. Dixon and Mary N. Dixon, husband and wife, as grantor and recorded on October 18, 1966, in book M-66 at page 10108-109 of the Mortgage Records of Klamath County, Oregon, conveying real property situated in said county described as follows:
