KNOW ALL MEN BY THESE PRESENTS, That CLEO L. CASTEEL and BETTY D. CASTEEL, husband and wife,

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by ROBERT L. TOLER and JERRINE M. TOLER, husband and wife,

hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

The following described real property in Klamath County, Oregon:

A parcel of land situate in Lot 28, Section 9, Township 35 South, Range 7 East of the Willamette Meridian, more particularly described as follows:

Beginning at the Northwest corner of said Lot 28; thence along the North line of Lot 28 South 89°53-3/4' East 333.44 feet to the TRUE POINT OF BEGINNING; thence continuing along the Northline of Lot 28 South 89°53-3/4' East 333.44 feet to a point; thence South to a point on the South line of Lot 28 that bears South 89°49-3/4' East 667.50 feet from the Southwest corner of said Lot 28; thence along the South line of Lot 28 North 89°49-3/4' West 333.75 feet to a point; thence North to the true point of beginning.

SUBJECT To reservations and restrictions of record and easements and rights of way of record and those apparent on the land;

SUBJECT To reservation of subsurface rights excepting water.

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever.

And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except as hereinabove set forth;

and that grantor will warrant and forever defend the above granted premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$1,250.00
