SUBJECT TO: Acreage and use limitations under provisions of the United States and regulations issued thereunder, contracts, liens, assessments, rules and regulations for irrigation, drainage and sewage, reservations, restrictions, conditions, easements and rights of way of record, and those apparent on the land, and all future real property taxes and assessments.

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever. And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except as above set forth

and that grantor will warrant and forever defend the above granted premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances. The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 24,000.00

However, the actual consideration consists of the property of the grantor, which is the whole of the property of the grantor, and the grantor hereby warrants and forever defends the same against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
