 hereinafter called grantee, and unto grantees heirs, successors and assigns all of the grantor's right, title  
 and interest in that certain real property with the tenements, hereditaments and appurtenances thereunto  
 belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

A tract of land situated in the NE<sup>1/4</sup> SW<sup>1/4</sup> of Section 3  
 Township 36 South, Range 6 East of the Willamette  
 Meridian, and described as follows:
