BOUNDARY LINE AGREEMENT

THIS AGREEMENT is made and entered into this 10th day of June, 1970, by and between WEYERHAEUSER COMPANY, a Washington corporation, herein called "Weyerhaeuser," and L. V. HOWARD and LETHA WAIVE HOWARD, husband and wife, herein called "Howards."

RECITALS:

A. Weyerhaeuser is the owner of the South Half of Northeast Quarter ($S\frac{1}{2}$ of $NE\frac{1}{4}$), the Northeast Quarter of Southwest Quarter ($NE\frac{1}{4}$ of $SW\frac{1}{4}$), and the Northwest Quarter of Southeast Quarter ($NW\frac{1}{4}$ of $SE\frac{1}{4}$) of Section Twenty-six (26), Township Thirty-nine (39) South, Range Seven (7) East of Willamette Meridian, in Klamath County, Oregon.

B. Howards own the Northeast Quarter of Southeast Quarter ($NE\frac{1}{4}$ of $SE\frac{1}{4}$) and a portion of the Southeast Quarter of Southwest Quarter ($SE\frac{1}{4}$ of $SW\frac{1}{4}$) and the South Half of Southeast Quarter ($S\frac{1}{2}$ of $SE\frac{1}{4}$), as particularly described in a Statutory Warranty Deed recorded in Volume M 70 of Deeds, Page 2243, Records of Klamath County, Oregon, all in Section Twenty-six (26), Township Thirty-nine (39) South, Range Seven (7) East of Willamette Meridian, in Klamath County, Oregon.

C. The parties hereto desire to set forth the surveyed boundary of the contiguous property hereinabove described.

NOW, THEREFORE, the parties hereto agree that the following described line is the true and actual boundary between Weyerhaeuser's ownership described in Recital A. above and Howards' ownership described in Recital B. above:

Beginning at the quarter section corner on the East line of Section 26, Township 39 South, Range 7 East of Willamette Meridian, in Klamath County, Oregon;
thence West 1,320.00 feet to a $5/8$ th inch iron rod;
thence South 1,310.93 feet to a $5/8$ th inch iron rod;
thence West 2,313.45 feet to a point marked by a $5/8$ th inch iron rod, which is on the line described in said Statutory Warranty Deed, recorded in Volume M 70 of Deeds, Page 2243, Records of Klamath County, Oregon, and in a Statutory Warranty Deed, recorded in Volume M 70 of Deeds, Page 2240, Records of said County.
