WARRANTY DEED TO CREATE ESTATE BY THE ENTIRETY

This Indenture Mitnesseth, THAT OSCAR E. SHIVE and GEORGIA B. SHIVE, husband and wife,

hereinafter known as grantor ${\bf s}$, for the consideration hereinafter stated grant, bargain, sell and convey unto have bargained and sold, and by these presents do

GARTH KEEFER and CHRISTINA KEEFER, husband and wife, grantees, the following described premises, situated in Klamath County, Oregon, to-wit:

The following described real property in Klamath County, Oregon: All that portion of Lots 9 and 10 in Block 10 of EWAUNA HEIGHTS ADDITION to the City of Klamath Falls, Oregon, described as follows: Beginning at the most Northerly corner of said Block 10; thence Southerly along the Westerly line of Second Street 48.8 feet, more or less, to the center of the concrete driveway, which said concrete driveway is 8.7 feet in width; thence Westerly parallel with Jefferson Street along the center line of the driveway 104.8 feet to the Westerly line of Lot 9; thence Northerly along said lot line 48.8 feet, more or less, the Northwest corner of said Lot 9: thence Fasterly along the Southerly line to the Northwest corner of said Lot 9; thence Easterly along the Southerly line of Jefferson Street, 104.8 feet to the place of beginning, together with the use of all of said concrete driveway for driveway purposes only.
