1 KNOW ALL MEN BY THESE PRESENTS, That Short Enterprises, Inc., an Oregon  
2 corporation, Grantor, in consideration of \$1.00 to it in hand paid by Klamath  
3 Irrigation District, grantee, does hereby give and grant unto said grantee  
4 the perpetual easement and right of way for spill ditch purposes over and  
5 across the strip of land 20 feet in width adjacent to the Westerly line of the  
6 A-7-Lateral and extending from the Northerly line of the A-7-C Lateral  
7 Northerly a distance of 650 feet, more or less, to the Southerly line of the  
8 1-C-1 -C Drain, said strip of land being situate in Southeast quarter of South-  
9 east quarter of Section 24, Twp.39 S.R. 9 E.W.M., in Klamath County, Oregon,  
10 together with the perpetual right to enter into and upon said property for the  
11 purpose of constructin, operating, maintaining and repairing said spill ditch.
