ORDINANCE NO. 5778

AN ORDINANCE VACATING A PORTION OF CRATER STREET BETWEEN WOCUS STREET AND BUENA VISTA STREET, ALL IN THE CITY OF KLAMATH FALLS, OREGON; AND DECLARING AN EMERGENCY.

WHEREAS, on August 3, 1970, pursuant to Resolution No. 1847, the Common Council of the City of Klamath Falls, Oregon, held a hearing on a proposal to vacate a portion of Crater Street between Wocus Street and Buena Vista Street, all in the City of Klamath Falls, Oregon; and

WHEREAS, the Common Council of the City of Klamath Falls has determined that it is in the best interest of the City that said portion of Crater Street be vacated; therefore

THE CITY OF KLAMATH FALLS ORDAINS AS FOLLOWS:

Section 1.

That portion of Crater Street described below shall be and the same is hereby vacated.

Beginning at the southeast corner of Lot 1, Block 4, Buena Vista Addition to the City of Klamath Falls, Oregon; thence northwesterly 238.8 feet more or less to the northeast corner of Lot 2, Block 4 of said addition; thence northeasterly in a straight line 60.0 feet more or less to the northwest corner of Lot 8, Block 3, of said addition; thence southeasterly 281.8 feet more or less to the most south and west corner of Block 3 of said addition; thence southwesterly in a straight line 73.8 feet more or less to the point of beginning.

Section 2.

Time being of the essence, an emergency is declared to exist and this ordinance shall be in full force and effect from and after its passage and its approval by the Mayor.

Passed by the Common Council of the City of Klamath Falls, Oregon, this 17th day of August, 1970.
