AMENDMENT #7 TO THE RIGHT-OF-WAY AND ROAD USE AGREEMENT NO. M-660 AND O&C LOGGING ROAD RIGHT-OF-WAY PERMIT NO. M-660

Agreement between the UNITED STATES OF AMERICA acting through its agency, The Bureau of Land Management, and BOISE CASCADE CORPORATION-THE PRUDENTIAL INSURANCE COMPANY OF AMERICA

WITNESSETH:

WHEREAS, the UNITED STATES and ELK LUMBER COMPANY OF CALIFORNIA entered into Right-of-Way and Road Use Agreement M-660 on October 5, 1962, which agreement is recorded in the Klamath County Deed Records, Volume 341, Page 356, and in the Jackson County Deed Records, Volume 534, Page 317, and in Josephine County Deed Records, Volume 223, Page 413.

Said agreement was amended by an instrument titled Agreement #1, executed March 15, 1963, and recorded in the Jackson County Deed Records in Volume 542, Page 315, and also amended by an instrument titled Agreement #2, executed November 11, 1963, and recorded in the Jackson County Deed Records in Volume 556, Page 419, and also amended by an instrument titled Agreement #3, executed December 2, 1964, and recorded in the Jackson County Deed Records in Volume 578, Page 256, and also amended by an instrument titled Amendment #4, executed July 7, 1965, and recorded in the Jackson County Deed Records in Volume 591, Page 18, and also recorded in the Josephine County Deed Records in Volume 245, Page 582, and also amended by an instrument titled Amendment #5 executed January 28, 1970, and recorded in the Jackson County Official Records as Document #70-01177 and also recorded in the Josephine County Deed Records in Volume 268, Page 147, and also in the Klamath County Deed Records in Volume M-70, Page 4733, and also amended by an instrument titled Amendment #6 executed October 13, 1966, and recorded in the Jackson County Official Records in Document Number 66-11150 and said agreement was transferred and assigned to E L C Corporation-Elk Lumber Company on March 18, 1966. And said agreement has now been transferred and assigned to the Boise Cascade Corporation-The Prudential Insurance Company on June 13, 1967.

WHEREAS, the parties hereto desire to amend such right-of-way and road use agreement by including additional real property.

NOW THEREFORE, the parties hereto do mutually agree as follows:

- 1. That the real property described on the attached Schedule 1 D and 2 D shall hereafter be subject to the terms and conditions of the above-described agreement the same as if such property were included in Schedule 1 and 2 thereof.
 - 2. That Exhibit A and B be amended as follows:

"The Permittee and the United States agree that each party may construct, improve and maintain heliports, heliponds, and helipond appurtenances, and temporary logging landings upon the other party's lands described in Schedules 1 and 2 as amended, for forest management use by the constructing party, its agents, contractors and in the case of the United States its licensees; provided however, that prior to the construction of a heliport, helipond or temporary logging landing, approval of the location, design, access and flightways (if applicable) must be obtained in writing from the landowner and agreement must be reached as to the disposal of any timber on the site; and provided further, that said heliports and heliponds shall not be used for aerial logging or log transportation, the storage of fuel and other petroleum products or as a site for the construction of any hanger, shop or other buildings without the written approval of the landowner and subject to such additional terms and conditions as he may require. The Permittee and the United States also agree that each party, its agents, contractors and in the case of the United States its licensees, may use the other party's heliports and heliponds constructed upon any lands described in Schedule 1 and 2 as amended, under terms and conditions to be mutually agreed upon.






