WHEREAS, on the 27th day of February, 1935 on report and recommendation of the Oregon State Board of Forestry, the State Tax Commission, now known as the Department of Revenue entered an order classifying certain lands in Klamath County, Oregon, as reforestation lands; and

WHEREAS, a certain portion of said lands have been platted and recorded pursuant to ORS 92.120, and

WHEREAS, pursuant to ORS 321.295(4) such lands must be removed from Reforestation Classification; it is, therefore,

ORDERED, that the land hereinafter described, situated in Klamath County, Oregon, shall be and hereby is removed from said Reforestation Classification Order No. 36, and is subject to assessment for ad valorem property taxation; the land so removed from reforestation classification being specifically described as follows:

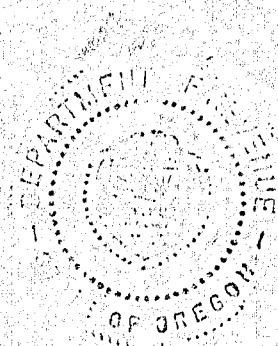
