verily believe.

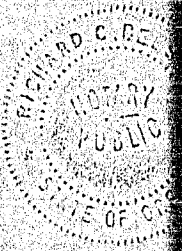

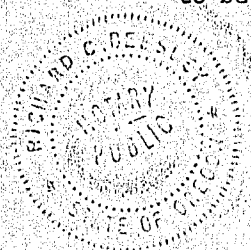
