ORDER.

WHEREAS, On the 13th day of July, 1970, the Board of Commissioners of Klamath County, Oregon, did on its own motion and pursuant to the provisions of ORS 368.565, declare its intention to vacate a County Road described in Commissioners' Journal II, Page 250, which said road was established in 1892; and

WHEREAS, The Board of County Commissioners did refer said matter to the County Engineer for his report, which report approved the vacation of said road as described in Journal II, Page 250; and


WHEREAS, The Affidavit of Earl E. Kessler has proved that proper Notice of Resolution to vacate and hearing thereon was properly posted on the Bulletin Board at the place of meeting of the Board of Commissioners and at three public places in the vicinity of the road proposed to be vacated; and

WHEREAS, The Board of County Commissioners did set the public hearing on the proposed vacation for the hour of 11:00 o'clock A.M., in the Board of Commissioners' Hearing Room, Courthouse. Klamath Falls, Klamath County, Oregon, on the 26th day of August, 1970; that notices of said hearing were posted on the 23rd day of July, 1970, which posting was more than thirty days prior to the time set for the hearing; and

WHEREAS, The hearing was held at 11:00 o'clock
A.M., on the 26th day of August, 1970, at which time it was

determined that said road was no longer used for road purposes; that said road has been fenced; that in many instances the course of said road cannot even be found; that other roads of County status have replaced the road proposed to be vacated; that the proposed vacation is to the benefit of the general public for the reason that said road is not being used; that the road would be burdensome and useless; that the County is not maintaining said road and that the public will be benefitted for the reasons above set forth; now, therefore,

IT IS HEREBY ORDERED That the County Road more particularly described as follows:

Commencing at the West end of the County
Bridge in the Town of Keno; thence Westerly up
the Main Street of said Town of Keno as located
and recorded, to the corner of Doten's fence;
thence Southeasterly following the main travelled
road as near as practicable to and past the farms
of Wesley Cole, W. R. Ramsey, L. H. Teeters, E.
Skaggs, E. J. Boyd, Nancy Decker, the late William
Decker; thence through the farm of D. L. Gordon
and the Fred Ringer Farm, formerly the John H.
Miller place, terminating at the State Line between the States of California and Oregon, at a
point 318 yards east of a stake on the line between
California and Oregon, marked 94M on the East side,
42L on the West side, 0 on the North side and C
on the South side.
