DEED OF PERSONAL REPRESENTATIVE

THIS INDENTURE WITNESSETH, That ANDREW J. HONZEL, JR., the duly appointed, qualified and acting personal representative of the Estate of Mary Lucile Honzel, Deceased, herein called "grantor", in consideration of the sum of SEVENTEEN THOUSAND SEVEN HUNDRED AND NO/100 DOLLARS to him paid, has bargained and sold and by these presents does grant, bargain, sell and convey to LEONARD L. BOGGS and ETHEL M. BOGGS, husband and wife, herein called "grantees", their heirs and assigns forever, all of the right, title and interest of the abovementioned estate in and to the following-described premises situated in Klamath County, State of Oregon, to-wit:

Lot 5, Block 43, HOT SPRINGS ADDITION to the City of Klamath Falls, Oregon, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon. SUBJECT TO: (1) 1970-71 taxes which are now a lien but not yet due and payable. (2) Reservations in the dedication of Hot Springs Addition. (3) Note and mortgage securing the same, including the terms and provisions thereof, executed by A. J. Honzel and Mary L. Honzel, husband and wife, to The First National Bank of Portland, a corporation, in the amount of \$15,100.00, dated June 20, 1958, recorded June 23, 1958, in Volume 182, Page 651, Mortgage Records of Klamath County, Oregon, the balance of which note and mortgage grantees assume and agree to pay according to the terms and provisions thereof,

together with all tenements, hereditaments and appurtenances hereunto belonging or appertaining, and all estate, right, title and interest in and to the same.
