

DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, That the undersigned trustee or successor trustee under that certain trust deed dated September 9, 1964, executed and delivered by Wilmer Allers and June B. Allers, husband and wife as grantor and recorded on September 10, 1964, in book 225 at page 510 of the Mortgage Records of Klamath County, Oregon, conveying real property situated in said county described as follows:

All that part of Lots 4, 5, 6 and 7 Block 29 in the Supplemental plat of Malin, that are not included within the boundaries of the Right of the U. S. Reclamation Service Canal, according to the official plat thereof on file in the records of Klamath County, Oregon.
