WHEREAS, On the 3rd day of September, 1970, the Board of Commissioners of Klamath County, Oregon, did on its own motion and pursuant to the provisions of ORS 368.565, declare its intention to vacate a portion of the Old Lake of the Woods County Road Traversing through the  $S^{1}_{2}$  Section 17, Township 36 South, Range 6 E., W.M., Klamath County, Oregon; and

WHEREAS, The Board of County Commissioners did refer such matter to the County Engineer for his report, which said report approved vacation of said portion of road; and

WHEREAS, The Affidavit of Earl E. Kessler has proved that proper Notice of the Resolution to vacate and the hearing thereon was posted on the bulletin board at the place of meeting of the Board of Commissioners and at three public places in the vicinity of the road to be vacated; and

WHEREAS, The Board of County Commissioners did set the public hearing on the proposed vacation for the hour of 10:30 o'clock A.M., in the Board of Commissioners' Hearing Room, Courthouse, Klamath Falls, Klamath County, Oregon, on the 7th day of October, 1970; and that said Notices were so posted on the 4th day of September, 1970, which said posting was more than 30 days prior to the time set for hearing; and

WHEREAS, The hearing was held at 10:30 o'clock A.M. on the 7th day of October, 1970, at which time it was determined that said road was not generally used by the public; that it appears that said road serves no one; that other more modern roads have replaced the road proposed to be
