ASSIGNMENT OF VENDEES' INTEREST IN CONTRACT

KNOW ALL MEN BY THESE PRESENTS, that JOHN WILKINSON and JUDITH WILKINSON, bushand and wife, hereinafter referred to as Assignors, in consideration of TEN DOLLARS and other valuable considerations to them in hand paid by CHARLES F. JOHNSON and DOROTHY R. JOHNSON, husband and wife, hereinafter referred to as Assignees, do by these presents, sell, assign, transfer, and set over unto Assignees all of their right, title, and interest in and to that certain contract dated October 21, 1969, wherein Mary H. Totton, a single woman, agreed to sell, and Assignors agreed to buy the following-described real property situate in Klamath County, Oregon, to-wit:

Lots 6, 7, 8, and 12 and those portions of Lots 9 and 11 lying Northerly of the following-described line: Beginning at a point on the Easterly line of said Lot 11 which lies N. 08 degrees 09' W. a distance of 120.0 feet from the Southeast corner of said Lot 11; thence S. 62 degrees 18' W. a distance of 86.2 feet to the Southeast corner of said Lot 9; thence S. 70 degrees 49' W. a distance of 143.2 feet to a point on the Westerly line of said Lot 9, said point being N. 31 degrees 17' W. a distance of 30.0 feet from the most Southerly corner of Lot 9;


