and State of Oregon, described as follows, to-wit:

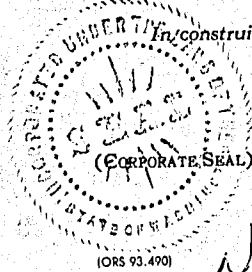
Lot 3 in Block 5 of Tract No. 1007, Winchester, according
