THIS AGREEMENT, made this 18th day of August, 1970, by and between JACK DUCKWORTH and GALENA MAE DUCKWORTH, his wife, Lessor and UNION OIL COMPANY OF CALIFORNIA, a corporation, Lessee.

## WITNESSETH:

WHEREAS, JOHN ZBINDEN leased to Lessee by that certain Service Station Site and Facilities Lease, dated May 22, 1956, and short form of lease thereof also dated May 22, 1956, and recorded September 14, 1956, in Volume 286, Page 531, Official Records of Deeds, Klamath County and as modified by that Modification of Service Station Site and Facilities Lease dated March 14, 1966 and recorded May 5, 1966, in Volume M-66, Index No. 6013, Official Records of Deeds, Klamath County and further modified by Modification of Service Station Site and Facilities Lease dated June 12, 1967, and recorded August 9, 1967 in Volume M-67, page 6160, Official Records of Deeds, Klamath County, respecting that certain real property situate in the County of Klamath, State of Oregon, described as follows:

Beginning at the intersection of the South line of Section 6, Township 29 South, Range 8 E, W.M., and the Easterly boundary line of Highway 97; thence East 10 feet; thence North 65 feet along Easterly boundary of said relocated Highway 97 to the true point of beginning; thence East 65 feet; thence North 100 feet; thence West 65 feet to the Easterly boundary of relocated Highway 97; thence South 100 feet along Easterly boundary of relocated Highway 97 to the true point of beginning;

together with the buildings and equipment now located or to be placed thereon by Lessor, as described in Exhibit A attached to said Service Station Site and Facilities Lease; and the interest of John Zbinden having been conveyed to Jack Duckworth and Galena Mae Duckworth effective August 21, 1967 by Contract of Sale also dated August 21, 1967.

NOW, THEREFORE, the parties do hereby agree that said Service Station

Site and Facilities Lease and short form of lease thereof, shall be and is hereby modified and amended as of the 18th day of August, 1970, in the manner and to the extent herein set forth, but in no other manner

or extent, to-wit: 1. Paragraph Three (3) RENTAL, of said lease is modified as follows:



Lessee agrees to pay Lessor each calendar month as rental for said premises a sum equivalent to TWO CENTS (2¢) per gallon for each gallon of -Lessee's -gasoline delivered at or upon said premises, or, at Lessee's option, dispensed therefrom during such month, said rental to be paid on or before the 20th day 3

2. Paragraph Two (2) TERM, of said lease provides that the term thereof shall commence the 1st day of June, 1956, and end the 31st day of May, 1961, which term was extended by letter dated November 12, 1960 to end the 31st day of May, 1966, and further extended by Modification dated March 14, 1966 to end May 31, 1967, and further extended by Modification dated June 12, 1967 to end May 31, 1969.

For the purpose of said paragraph, it is agreed that month to month tenancy since May 31, 1969 is abated and Lessee is further the term of said lease is hereby extended for an additional three (3) years commencing August 18, 1970 and ending August 17, 1973.

3. Paragraph Four (4) EXTENSION, of said lease is hereby reinstated to read as follows:

As further material consideration for the execution of this modification, Lessee is hereby granted the exclusive right and option to extend this lease for such additional term as Lessee may declare at its further option, but which term shall in no event exceed three (3) years, upon the same terms and conditions and for the same rental hereinbefore provided. Written notice of the exercise of said option to extend this lease, together with the declared term of said extension, shall be given at least sixty (60) days prior to the expiration of the term hereof.

As modified herein, all the terms, covenants, conditions and agreements of said leases are hereby reaffirmed by the parties hereto and shall remain in full force and effect.
