AGREEMENT ESTABLISHING BOUNDARY

WITNESSETH:

FOR AND IN CONSIDERATION of the covenants and agreements herein contained and other good and valuable consideration paid by each of the parties to the other, it is acknowledged, understood ani agreed as follows:

Hagels are the owners of the E_2^1 SW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 35, Township 38 S., R. 9 E.W.M., Klamath County, Oregon.

Campbells are the owners of the $NW_1^1NE_4^1$, Section 35, Township 38 S., R. 9 E.W.M., Klamath County, Oregon.

There is or may be some discrepancy as to the location of the boundary line between the above-described parcels extending approximately 646 feet across the northerly side of the parcel owned by Hagels and approximately 646 feet along the easterly half of the southerly boundary of the property owned by Campbells.

It is further mutually agreed and understood by and between the parties hereto that the line of the existing fence, which has been in existence for many years last past, between the parcels hereinabove described belonging to Hagels and Campbells, is and forever hereafter shall be the true and actual boundary between the parcels of real property hereinabove described.
