SHERIFF'S DEED

THIS DEED made February 26, 1971, between J. M. BRITTON, Sheriff of Klamath County, Oregon, hereinafter called Grantor and FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF KLAMATH FALLS, a Federal corporation, hereinafter called Grantee,

WITNESSETH:

WHEREAS, in a suit in the Circuit Court of the State of Oregon for Klanath County, Oregon, between FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF KLANATH FALLS, a Federal corporation, Plaintiff, and MAE D. HEARN, formerly Mae D. Wasson; GERALD L. WOODS and HAZEL J. WOODS, husband and wife; DEPARTMENT OF REVENUE OF THE STATE OF OREGON; CARTER-JONES COLLECTION SERVICE, INC., an Oregon corporation; SEWING CENTER SUPPLY CO., an Oregon corporation; FEDERAL SIGN AND SIGNAL CORPORATION, a Delaware corporation; and FLOYD DOUGLAS REYNOLDS who is also known as Douglas Reynolds, and ARLENE D. REYNOLDS, husband and wife Defendants, a judgment and decree was entered on December 30, 1969, for the foreclosure of a mortgage on the real property described below; and

WHEREAS, the Court thereafter issued a writ of execution and pursuant thereto on February 3, 1970, all of the interest of the Defendants in the real property was sold at public auction, subject to redemption, in the manner provided by law, for the sum of \$9,515.77, to First Federal Savings and Loan Association of Klamath Falls, a Federal corporation, the highest bidder; and

WHEREAS, the Sheriff, after receiving from the purchaser the sum of money so bid, duly executed and delivered to the purchaser a Certificate of Sale; and

WHEREAS, the Sheriff then filed the return of sale with the Court and an Order confirming the sale was entered February 19,1970; and

WHEREAS, the time for redeeming as required by law has expired, the real property has not been redeemed from the sale, and the Grantee herein is the owner and holder of the Certificate of Sale and has delivered the Certificate to Grantor.

NOW, THEREFORE, in consideration of the sum paid for the real property

Grantor does hereby convey to Grantee all of the interest the Defendants had
