DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, That the undersigned trustee or successor trustee under that certain trust deed dated January 11, 1963, executed and delivered by JAY'S GROCERY SERVICE, a co-partnership consisting of J. S. Humphries and Raymond A. Migliaccio as grantor and recorded on January 17, 1963, in book 215 at page 208 of the Mortgage Records of Klamath County, Oregon, conveying real property situated in said county described as follows:
