do hereby grant, bargain, sell and convey unto the said grantee S., their heirs and assigns, all the following real property, with the tenements, hereditaments and appurtenances, situated in the County of Klamath and State of Oregon, bounded and described as follows, to-wit:

Beginning at a point in the Northerly boundary of Tract 33, Altamont Small Farms, as shown by the plat on record in the office of the County Clerk of Klamath County, Oregon, said point being 107 feet distant from the Northwest corner of said tract, and running thence South 88°46' East along the said Northerly boundary of said Tract 107 feet; thence South 0°11' West 200 feet, more or less, to a point in the Southerly boundary of said tract; thence North 88°46' West along the Southerly boundary of said tract 107 feet; thence North 0°11' East 200 feet, more or less, to the point of beginning, and containing one-half acre, more or less, and being a portion of said Tract 33 Altamont Small Farms, Klamath County, Oregon.
