2 THIS INDENTURE WITNESSETH, That TERRY A. KUHLMAN and SHERRILLEE KUHLMAN,
3 husband and wife, Grantors, for the consideration hereafter set forth, have
4 bargained and sold and by these presents do grant, bargain, sell and convey
5 unto KLAMATH COUNTY SCHOOL DISTRICT, a County School District organized and
6 existing under the laws of the State of Oregon, its successors and assigns,
7 the following described premises situated in Klamath County, Oregon to wit:

8 Beginning at the intersection of the North line of Landis Park
9 and the Southeasterly line of the U.S.R.S. Drain, said point
10 also being the Northwest corner of Lot 21 of Landis Park; thence
11 North 25°45' East along the Southeasterly line of said U.S.R.S.
12 Drain a distance of 163.2 feet to its intersection with the East-
13 West center line of Section 10; thence North 88°44' East along
14 said center line a distance of 635.8 feet to the Westerly line of
15 the U.S.R. F-7 Lateral; thence South along the said West line a
16 distance of 144.5 feet to the North line of Landis Park; thence
17 South 88°44' West along said North line to the point of beginning;
18 being in the NE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 10, Township 39 South, Range 9 E.W.M.
19 Klamath County, Oregon.

20 Subject to contract and/or lien for irrigation and/or drainage and
21 to inclusion in the South Suburban Sanitary District and the reg-
22 ulations and assessments thereof.
