THOMAS and VIRGINIA C. THOMAS, husband and wife, of Klamath Falls, Oregon, does hereby grant, bargain, sell and convey unto the said WILLIAM B. THOMAS and VIRGINIA C. THOMAS, husband and wife, and unto their heirs and assigns, all its right, title and interest in and to the following-described parcel of real property, situate in the County of Klamath, State of Oregon, to-wit:


