

DEED OF GIFT

THIS INDENTURE WITNESSETH, that ELDON V. STIVERS and PEGGY M. STIVERS, husband and wife, Grantors, in consideration of Love and Affection to them paid, do hereby give, grant and convey unto RHONDA L. ROSTEROLLA and EUGENE D. ROSTEROLLA, wife and husband, Grantees, the following described premises, situated in Klamath County, Oregon, to-wit:

Lot 3 of Sportsman Park, Klamath County, Oregon, according to the official plat thereof on file in Klamath County, Oregon.

Subject to: The agreement of January 25, 1924, recorded February 15, 1924, in Vol. 63 at page 460 of Klamath County, Oregon, deed records concerning the operation of the dam and control of the water levels of Upper Klamath Lake; Reservations contained in the dedication of Sportsman Park; Any easements of record; And to building and use restrictions contained in agreement between grantors and grantees as follows:

(1) That grantees will not suffer or permit any unlawful, unsightly or offensive use to be made of said premises nor will they suffer or permit anything to be done thereon which may be or become a nuisance or annoyance to the neighborhood.

(2) That they will use said premises solely as a residence or summer home site.

(3) That each said lot shall never be subdivided nor shall any less portion than the whole of said lot ever be sold, leased or conveyed, and that no building except one summer home or residence and the usual and necessary outbuildings thereto shall ever be erected thereon.

(4) That no building shall ever be erected within 10 feet of any exterior property line.

(5) That the foregoing covenants are appurtenant to and for the benefit of each and every other lot in said Sportsman Park and shall forever run with the land and shall bind the premises herein conveyed for the benefit of each and every other lot in said addition and the foregoing covenants and restrictions shall be incorporated in and made a part of each and every other deed or conveyance hereafter executed for the purpose of conveying these premises.

WE HEREBY CERTIFY THAT THIS IS A GIFT AND THAT NO CONSIDERATION AS DEFINED BY CHAPTER 7 OF OREGON LAWS 1967 SPECIAL SESSION HAS BEEN PAID FOR THIS PROPERTY.

TO HAVE AND TO HOLD the said premises with their appurtenances unto the said Grantees as an Estate by the Entirety forever.
