A parcel of land 60 feet in width for public road purposes being in the E 1/2 of Section 9, Township 38 South, Range 10 E., W. M., 30 feet measured at right angles on either side of the following described centerline.

Beginning at the East 1/4 corner of Section 9, Township 38 South, Range 10 E., W. M.; thence N.89°55'W. 208.71 feet to the true point of beginning of this description; thence N.89°55'W. 1054.99 feet more or less to the East right-of-way line of the Gordon Lane as presently constructed.
