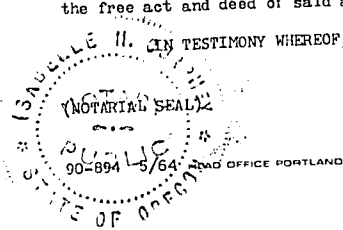
Lot 1, Block 9, all in Tract 1003, known as Third Addition to MOYINA, Klamath County, Oregon.
