On April 8, 1964, a Drift Fence Easement, hereinafter designated as the "Original Easement", was granted by WEYERHAEUSER COMPANY, therein designated as "Weyerhaeuser", to the UNITED STATES OF AMERICA, therein designated as "Government".

The parties mutually agree that the Original Easement shall be and is hereby supplemented to include additional drift fence and cattle guard on the additional Weyerhaeuser land;

- NE $\frac{1}{4}$ NW $\frac{1}{4}$ ; W $\frac{1}{2}$ SW $\frac{1}{4}$  - Section 10-T37S-R16E

and Klamath County all in Lake County, Oregon, located approximately as shown on the attached "Exhibit A".

Except as herein expressly provided, all of the terms and conditions of the Original Easement, as supplemented, shall remain unmodified.


