



9 NOTICE IS HEREBY GIVEN that VESTON CASEY claims a lien upon two Guernsey  
10 milk cows, one Guernsey steer and one Welch Breed black pony for and on account  
11 of depasturing and feeding expended and performed upon the above described  
12 property in Klamath County, Oregon, as follows:

13 Five months of pasture feeding of said livestock.  
14 That the name of the owner, or reputed owner thereof is Chester Baker. That  
15 Chester Baker requested said service. That said depasturing and feeding were  
16 so expended and performed upon the said chattel property by claimant between  
17 February 28, 1971 and July 1, 1971, and the rendition and performance of said  
18 claimant was closed on July 1, 1971. That thirty days have not elapsed since  
19 said services were expended on said chattel. That the amount claimant demands  
20 for said depasturing and feeding so expended and furnished is \$500.00. That no  
21 part thereof has been paid, except none. That there is due and remaining un-  
22 paid thereon, after deducting all just credits and offsets, the sum of \$500.00,  
23 and the further sum of \$5.00 costs for the preparation of said lien notice,  
24 (provided said lien claim has not been paid in full prior to the expiration of  
25 the time allowed by law for the filing of notice thereof.) In which amount said  
26 claimant now claims a lien upon said chattel property.
