SATISFACTION OF MORTGAGE

KNOW ALL MEN BY THESE PRESENTS that I, EFFIE A. NABOWER, formerly Effie A. Abbott, hereby certify and declare that certain Mortgage dated July 20, 1951 made and executed by Greer F. Drew and Faye E. Drew, his wife, Frank P. Drew and Virginia M. Drew, his wife, Lloyd A. Drew and Mary Z. Drew, his wife, and Cecil P. Drew and Evelyn L. Drew, his wife, as Mortgagors, to Julian R. Abbott and Alice T. Abbott, as Mortgagees with right of survivorship, and recorded on July 24, 1951 in Volume 140 at Page 332 of the Mortgage Records of Klamath County, Oregon, together with the Note thereby secured, is fully paid, satisfied and discharged.

Said Julian R. Abbott became the sole owner and holder of the above-mentioned Mortgage and Note upon the death of his wife, Alice T. Abbott, in approximately 1963.

Said Julian R. Abbott, subsequent to the death of Alice T. Abbott, married the undersigned and by an Agreement between Julian R. Abbott and the undersigned dated January 16, 1969 and recorded January 20, 1969 in Volume M69 at Page 480 of the Mortgage Records of Jackson County, Oregon, Julian R. Abbott assigned to the undersigned a one-half interest in said Mortgage and Note, and it was agreed said instruments would thereafter be owned by Julian R. Abbott and the undersigned jointly, with right of survivorship.

Julian R. Abbott died at Medford, Oregon on July 7, 1969 and the undersigned thereupon became the sole owner
