TERMINATION OF EASEMENT

WHEREAS, Frank W. Obenchain and Ruth Obenchain, his wife, granted to the United States of America an easement for a road, dated June 18, 1965 and recorded in Klamath County, June 25, 1965, in Book 362, page 447, and recorded in Klamath County June 6, 1966, in Book M-66, page 5868, which easement contained the following provisions: Provided, however, that if for a period of five (5) years the Grantee shall cease to use the road, or parts thereof, for the purposes granted, or shall abandon the same, then, in any such events, the premises traversed thereby shall be freed from said easement, or parts thereof, as fully and completely as if this deed had not been made. In the event of such non-use for the period stated, the Regional Forester shall furnish to the Grantor a statement in recordable form evidencing such non-use, and

WHEREAS, the undersigned has determined that the easement has not been used by the United States of America for a period of more than five (5) years, that the road has not been preserved or maintained during said period for future use, and that the United States of America has no further need for said easement.

NOW THEREFORE, this instrument is executed for the purpose of showing that the United States of America has not used the easement, or any segment thereof, for a period of more than five (5) years, that it has not preserved or maintained the road thereon for future use during said period, that it has no further need for the easement, and that the easement pursuant to its provisions has ceased and terminated and the United States of America does not have or claim any right, title or interest therein.

IN WITNESS WHEREOF, the United States of America, by its Regional Forester, Forest Service, Department of Agriculture, has executed this Indenture on this 13 day of July, 1971.
