(5) PARCEL I: Beginning at a point on the Westerly right of way line of the Dalles California Highway, which lies South 19°24' East, a distance of 9005 feet from the iron axle which marks the Southeast corner of Lot 1, Block 7, Chemult, Oregon, and running thence continuing South 19°24' East along the Westerly right of way line of the Dalles California Highway a distance of 90 feet and along the arc of a 2°56' curve to the left a distance of 10 feet; thence South 70°36' West a distance of 300 feet to an iron pin; thence North 19°24' West a distance of 100 feet to an iron pin; thence North 70°36' East a distance of 300 feet, more or less, to the point of beginning, said tract containing .69 acres more or less, in the SW 1/4 of Section 21, Township 27 South, Range 8 East W.M.

PARCEL II: A tract of land described as follows: Beginning at a point on the Westerly right of way line of the Dalles California Highway which lies South 19°24' East a distance of 1095 feet and along the arc of a 2°56' curve to the left a distance of 10 feet from the iron axle which marks the Southeast corner of Lot 1, Block 7, Chemult, Oregon, and running thence continuing Southeast along the arc of a 2°56' curve to the left a distance of 100 feet to a point; thence South 70°36' West a distance of 303.1 feet to an iron pin; thence N 19°24' West a distance of 100 feet to an iron pin; thence N 70°36' S a distance of 300 feet, more or less, to the point of beginning, said tract containing .69 acres, more or less, in the SW 1/4 of Section 21, Township 27 S.R. 9 E.W.M.

PARCEL III: A tract of land described as follows: Beginning at a point on the Westerly right of way line of the Dalles California Highway which lies S 19°24' East a distance of 1095 feet and along the arc of a 2°56' curve to the left a distance of 110 feet from the iron axle which marks the Southeast corner of Lot 1, Block 7, Chemult, Oregon, and running thence, continuing Southeast along the arc of a 2°56' curve to the left a distance of 190.2 feet to an iron pin on the Westerly right of way line of the Dalles California Highway on the South section line of Section 21, Township 27 S.R. 8 E.W.M.; thence S 39°12' West along the Section line a distance of 340.9 feet to an iron pin which lies N 39°12' East along the Section line a distance of 764.5 feet from the Southeast corner of said Section 21; thence N 19°24' West a distance of 61.1 feet to an iron pin; thence N 70°36' East a distance of 303.1 feet, more or less, to the point of beginning, said tract containing 1 acre, more or less, in the SW 1/4 of Section 21, Township 27 S.R. 8 E.W.M.
