ARTICLES OF ASSOCIATION OF

WHEREAS, Grayco Land Escrow, Ltd., has caused to be created an Association of Property Owners of Oregon Pines Subdivision, said Articles of Association thereof recorded in Volume M-71, Page 3898, records of County Recorder of Klamath County, Oregon, and:

WHEREAS, Grayco Land Escrow, Ltd., as owner of all of the parcels in said Subdivision is desirous of amending said Articles,

NOW, THEREFORE:

The Articles of Association of Oregon Pines Owners Association as recorded in Volume M-71, Page 3898, is hereby amended in the following particulars, and no others, to wit:

- A. Section 2 of Article 1 of said Articles, as recorded, is hereby deleted in its entirety, and the following Section 2 of Article 1 shall be substituted in its place and stead:

Section 2. The purpose and objects of the Association shall be to provide for the operation, maintenance, repair, rebuilding or rehabilitation of roads, streets, access roads and public ways to, in, and through Oregon Pines Plat, Klamath County, Oregon, for the benefit of members of the Association who have purchased lots from Grayco Land Escrow, Ltd., a California corporation.

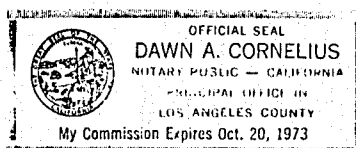
