RE-ASSIGNMENT

KNOW ALL MEN BY THESE PRESENTS, that UNITED STATES NATIONAL BANK OF OREGON, Assignor, in consideration of Ten Dollars to it paid by PAUL D. HESS and HELEN E. HESS, husband and wife, Assignees, does by these presents re-assign and transfer to said Assignees all of the Assignor's right, title and interest in and to that certain agreement dated July 21, 1966, wherein said Assignees agreed to sell, and Van L. Morrisett and Louise L. Morrisett, husband and wife, as joint tenants with the right of survivorship, agreed to purchase the following described real property in Klamath County, Oregon, to-wit:

A parcel of land situate in the NE $\frac{1}{4}$ of Section 32, Township 39 South, Range 8 East W.M., more particularly described as follows:

Beginning at the Northeast corner of the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$, of Section 29 said Township and Range; thence North 89 degrees 19.9' West 368.0 feet to a point; thence South 6 degrees 21' East 2571.58 feet to a point; thence North 74 degrees 20.9' East 726.31 feet to the true point of beginning of this description; thence continuing North 74 degrees 20.9' East 703.07 feet to a point; thence South 0 degrees 53' West 663.17 feet to a point; thence South 72 degrees 14.4' West 648.52 feet to a point; thence North 4 degrees 11.3' West 672.95 feet to the true point of beginning of this description,

which said contract was assigned by said Paul D. Hess and Helen E. Hess to said United States National Bank of Oregon, Assignor herein, as security for the payment of a certain note (or notes) made and executed by said Paul D. Hess and Helen E. Hess, husband and wife, to said United States National Bank of Oregon, as Payee; provided, however, that it is understood and agreed that this re-assignment is intended solely to release said contract as security for said loans, but that said note (or notes) shall remain in full force and effect until it (or they) shall be fully paid.

TO HAVE AND TO HOLD the same unto the Assignees, their heirs and assigns forever.


