ORDINANCE NO. 5930

AN ORDINANCE VACATING A PORTION OF HARRIMAN STREET BETWEEN LYTTON STREET AND "F" STREET, NOW GENERALLY KNOWN AS PRESCOTT STREET, ALL IN THE CITY OF KLAMATH FALLS, AND DECLARING AN EMERGENCY.

WHEREAS, on September 7, 1971, pursuant to Resolution No. 1959, the Common Council of the City of Klamath Falls, held a public hearing on a proposal to vacate a portion of Harriman Street between Lytton Street and "F" Street, now generally known as Prescott Street, all in the City of Klamath Falls, Oregon.

WHEREAS, the Common Council of the City of Klamath Falls has determined that it is to the best interest of the City and its inhabitants that a portion of Harriman Street between Lytton Street and "F" Street, now generally known as Prescott Street, as shown on the original plat of "Lakeview Addition to the City of Klamath Falls, Oregon" be vacated.

NOW, THEREFORE, THE CITY OF KLAMATH FALLS ORDAINS AS FOLLOWS:

Section 1.

That portion of Harriman Street between Lytton Street and "F" Street, now generally known as Prescott Street, described below as parcel 1 be, and the same are hereby vacated.
Parcel 1:

Beginning at the southeast corner of Block 66, Lakeview Addition to the City of Klamath Falls; thence, north along the east line of Block 66 a distance of 173 feet to the northeast corner of Block 66; thence, east a distance of 80 feet to the northwest corner of Block 67; thence, south along the west line of Block 67 a distance of 173 feet to the southwest corner of Block 67; thence, west a distance of 80 feet to the true point of beginning.

RESERVING, however, to the City of Klamath Falls a 16 foot wide easement between the said Lytton Street and "F" Street centered over the existing sanitary sewer and its future extension to the south, the alignment of said future extension to be a straight line continuation of the existing alignment. The existing alignment is located approximately 12 feet from and parallel to the said west line of Block 67.

Time being of the essence, an emergency is declared to exist, and this ordinance shall be in full force and effect from and after its passage and its approval by the Mayor.

Passed by the Common Council of the City of Klamath Falls, Oregon this 20th day of September, 1971.
