**KNOW ALL MEN BY THESE PRESENTS, That GERALD WEIPERT and CATHERINE WEIPERT, husband and wife,**

hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantees and grantees' heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Lot 6 in Block 1 of SUNSET VILLAGE, Klamath County, Oregon.

SUBJECT TO: 1971-72 real property taxes which are now a lien, but not yet payable, and, all future real property taxes and assessments; contracts, liens, assessments, rules, regulations and laws for irrigation, drainage and sewage; reservations, restrictions, conditions, set back lines, easements and rights of way of record, and those apparent on the land.

and that grantor will warrant and forever defend the above granted premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
