SCHWEIGER and EDNA MARGARETTA SCHWEIGER, and unto their heirs and assigns, all its right, title and interest in and to the following described parcel of real estate situated in Klamath County, Oregon:

Lot 9 and the Southeasterly half of Lot 8, HIGHLAND PARK, Klamath County, Oregon, more particularly described as follows:

Beginning at the Northeasterly corner of Lot 8; thence Southwesterly along the Easterly line of said Lot 200 feet to the Southeasterly corner thereof; thence Northwesterly along the Southwesterly line of said Lot a distance of 36 feet to a point; thence Northeasterly and parallel with the Easterly line of said Lot a distance of 200 feet to a point on the Northeasterly line of said lot; thence Southeasterly along the Northeasterly line of said Lot a distance of 36 feet to the point of beginning.

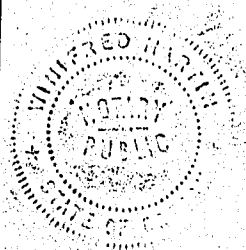
