

TERMINATION OF EASEMENT

THIS TERMINATION OF EASEMENT is made this 4 day of October 1971, by the UNITED STATES OF AMERICA, through the Acting Regional Forester, Forest Service, Department of Agriculture, hereinafter referred to as "Government", to Weyerhaeuser Company, hereinafter referred to as "Cooperator".

WHEREAS, by Easement dated September 21, 1970, recorded in Volume M71, Page 2951, Klamath County Deed Records and Page 481, Book 157, Lake County Deed Records, State of Oregon, Cooperator did grant to Government an Easement for the same roads, and for additional roads over the lands of Cooperator, and

WHEREAS, both Government and Cooperator do intend and agree that the Easement subsequently granted shall supersede the aforesaid Easement dated March 26, 1956, and shall govern and control the rights of Government and Cooperator for use of the lands and the roads thereon subject to such subsequent Easement,

NOW, THEREFORE, in consideration of the grant by Cooperator of such subsequent Easement and of Cooperator's acceptance of cancellation by Government of certain Special Use Permits which likewise were superseded by Easement granted by Government to Cooperator dated September 21, 1970, Government hereby releases, relinquishes and discharges to Cooperator all rights in the various roads created by and arising from or out of the aforesaid Deed dated March 26, 1956, it being intended to cancel such Deed.

THIS TERMINATION OF EASEMENT shall, however, have no effect on the rights granted to Government by the Easement dated September 21, 1970, all the terms, provisions and conditions of which shall remain and be fully effective.

IN WITNESS WHEREOF, the Grantor, by its Acting Regional Forester, Forest Service, has executed this Termination of Easement on the day and year first above written.
