

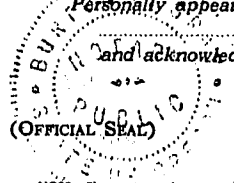
KNOW ALL MEN BY THESE PRESENTS, That Fred L. Herrick and Jerry C. Herrick,
