Beginning at a point on the northerly right-of-way line of the Dalles-California Highway which lies N 00°55' W 30 feet and N 89°21' E 602.4 feet along said right-of-way line from the center of said Section 2; thence continuing N 89°21' E 386.4 feet, more or less, to the west line of that property described in Deed Volume 149, Page 497, Klamath County Deed Records; thence N 00°46' W along said line 189.4 feet; thence S 89°21' W 386.4 feet, more or less, to the east line of that property described in Deed Volume 258, Page 258, Klamath County Deed Records; thence S 00°59' E 189.4 feet, more or less, to the point of beginning.

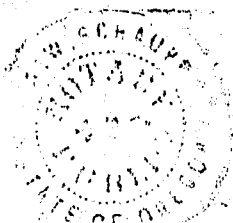
